Monthly Commentary

Global economic growth is starting to slow down somewhat, although the facts suggest that a double-dip recession will be avoided. In local currency terms, most Asian equities fell during July, with India and China the worst performers, both generating a negative return of 4.4%, while Australia was the star performer posting a gain of 2.4%. For sterling investors however the picture was somewhat different, as again currency was a key contributor to returns which resulted in a gain of 1.1% for the index over the month.

The 31st July marked the half-way point in the financial year of Witan Pacific. At this half-way stage Witan Pacific is continuing to performing strongly and over the past six months is 4.7% ahead of the benchmark on a NAV total return basis, while on a share price total return basis it is 6.2% ahead of benchmark.

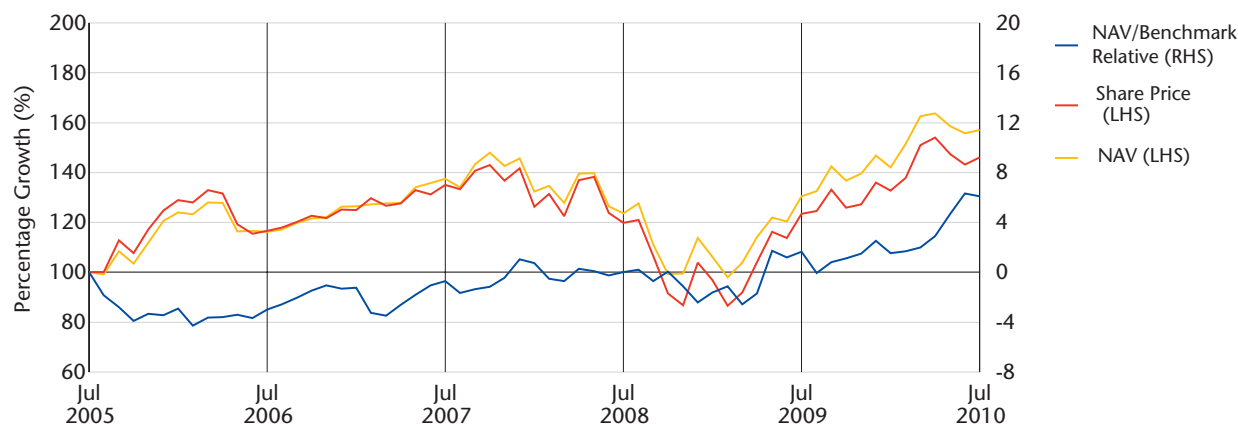
