

MONTHLY FACTSHEET MARCH 2018

Investment objective

Capital and income growth from a diversified portfolio of investments in the Asia Pacific region designed to outperform the MSCI AC Asia Pacific Free Index (£).

Monthly commentary

Equity market volatility remained elevated throughout March as investors grappled with the competing influences of solid economic and corporate fundamentals and the increasing fear of a trade war between the US and China. Markets were also spooked by an abrupt change in sentiment towards some of the world's largest technology stocks. The net result was a negative month for most indices with the US and Emerging Markets declining over 4% in sterling terms while Europe and Asia fared a little better, with declines of 3.3% and 3.9% respectively. The UK held up better at -1.8% but has lagged significantly since the Brexit vote. Indonesia was the weakest Asian market, with a decline of -8.6%. Australia (-7.2%), Philippines (-7.5%), India (-5.3%) and China (-5.0%) were also markedly lower while South Korea (+0.8%) was the only major market to gain ground with Samsung Electronics (Witan Pacific's largest holding) being Asia's only index heavyweight to record a positive return for the month. Minth Group, the second largest portfolio position, reported earnings during the month which fell a little short of analyst expectations and the stock fell nearly 20% on the news.

Over the first two months of the Company's financial year the NAV total return was -4.0% compared with the Benchmark's total return of -4.2%. The NAV total return over the last 12 months of +5.5% underperformed the +7.5% achieved by the Benchmark while the share price appreciated by +6.6%.

The recent sell-off appears rooted, not in inflationary fears, but in disappointing company specific news in the technology sector where complacency was most acute. This was exacerbated by President Trump's determination to ratchet up his protectionist rhetoric. As the dust settles following a more turbulent quarter, equities appear competitively priced for the selective and patient investor, particularly in the light of the recent improvement in corporate earnings and dividends. The principal risk is that politically-driven US decisions on trade policy undermine the current positive growth support for equities. By the same token, resolution of the present war of words would be a relief to markets after the recent correction.

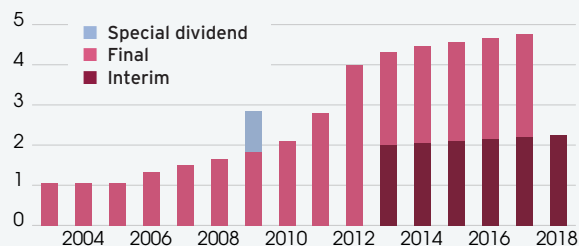

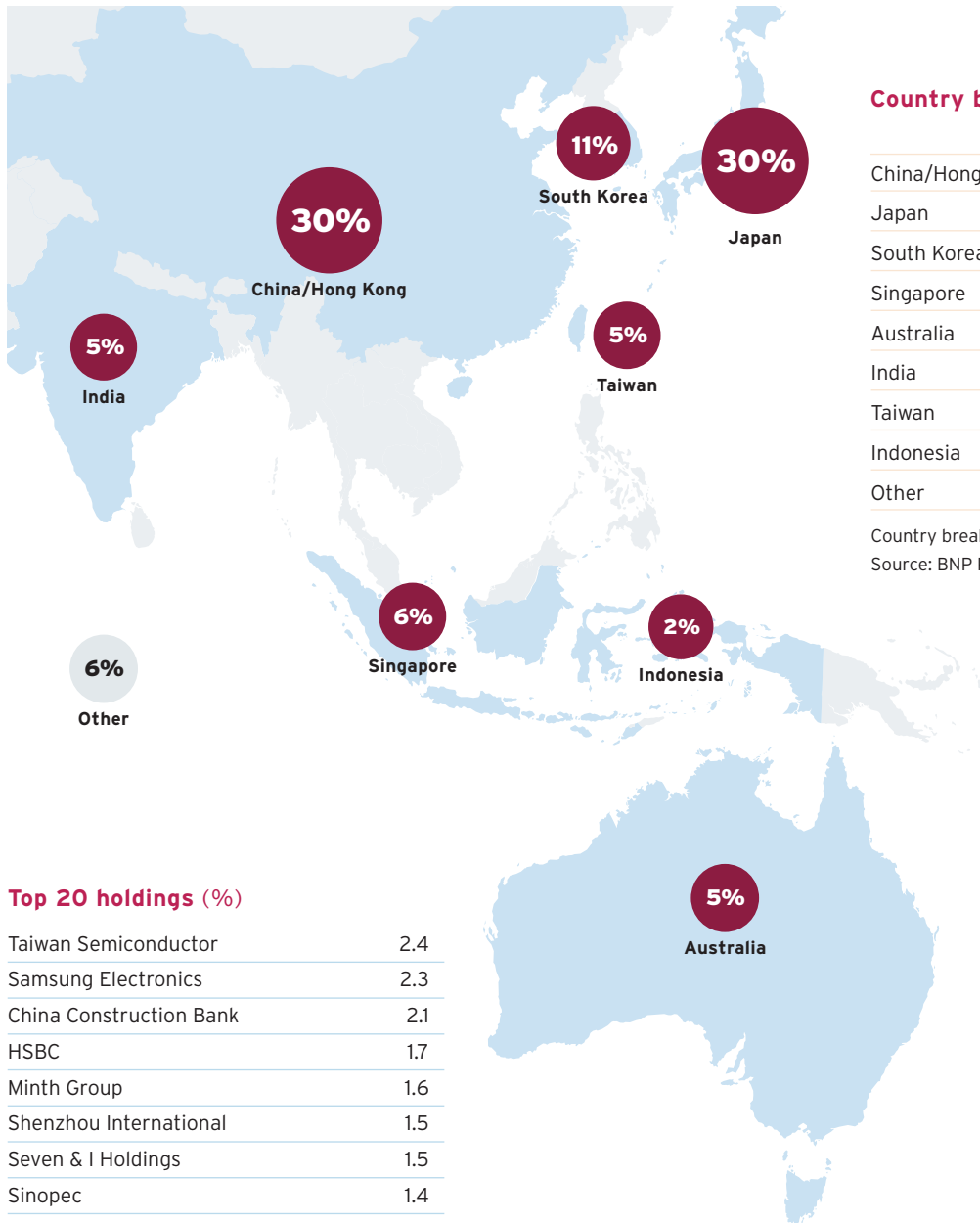

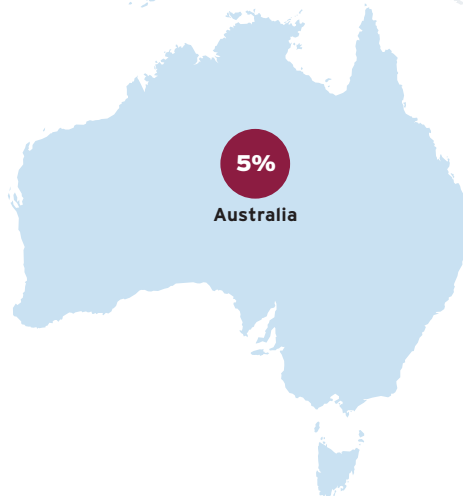

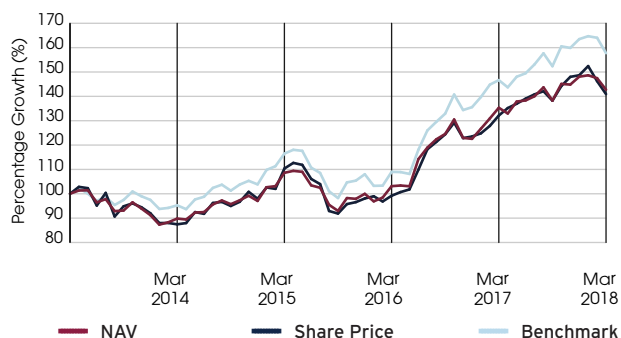

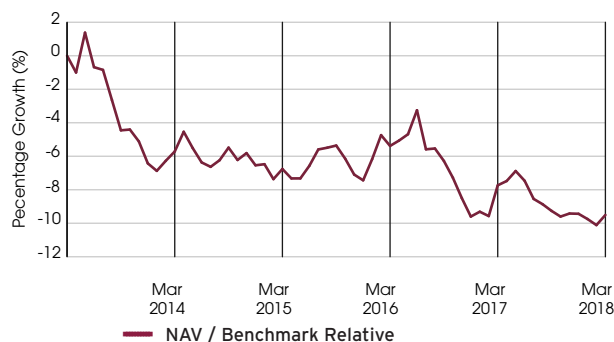
